Date: Two weeks from Easter, 51 Edward III [12 April 1377]. And afterwards one week from St Martin, 1 Richard [II] [18 November 1377].

Parties: **Thomas Dautry of Crauen'**, querent, and **Thomas**, son of **William de Rednesse**, knight, and **Katherine**, his wife, deforciant.

Property: The manor of **Rowall'** and 5 and a half marks of rent in **Rowall'**, **Kelyngton'**, **Egburgh'**, **Heuensale**, **Hathelsay**, **Burton'**, **Brayton'**, **Lede[.]**, **Brotherton'** and the vill of **Ponte Fracto**.

Action: Plea of covenant.

Warranty: Warranty by Thomas, son of William, and Katherine and the heirs of Thomas.

For this: Thomas Dautry has given them 200 marks of silver.
